MAJOR TRENDS IN THE MODERN AGE

Abstract

This research explores the life, thoughts, and poetry of John Keats, a key figure in the English Romantic period. The goal is to examine how Keats conveys his views on beauty, imagination, nature, love and death through his poems. Keats thought beauty and imagination could help people deal with pain and seek truth.

The study uses straightforward literary analysis. It looks at some of his well-known poems like Ode to a Nightingale, Ode on a Grecian Urn, To Autumn and When I Have Fears That I May Cease to Be. These poems show how Keats connects imagination with reality and beauty with truth. The paper also explains his famous idea of Negative Capability, which refers to the ability to accept mystery and uncertainty without need to find answers. The study finds that Keats' poems clearly reflect his philosophy in a powerful and beautiful way.

Introduction

John Keats was born on October 31, 1795, in London, England. His father died when he was just eight and his mother passed away when he was fifteen. Detailed Discussion

4. To Autumn

In this poem, Keats describes the season of autumn in beautiful, detailed images - ripening fruits, buzzing bees, and golden fields. of fearing death, he finds harmony in nature. He sees that every stage of life, even the end, has beauty and meaning. The poem's language is musical and calm, showing Keats's maturity as a poet and a person.

5. When I Have Fears That I May Cease to Be

This sonnet was written in 1818, before Keats fell seriously ill. In it, he expresses his fear of dying young before he can write all his poetry or experience deep love. He compares his unwritten ideas to grain that has not been harvested. This shows his anxiety about time and mortality.

However, the poem ends with peace and acceptance. Keats realizes that fame and love are small compared to the vastness of the world. This realization brings him calmness. The poem shows how Keats turned his fears into art. He accepted that death is part of life, and through poetry, he found a way to overcome it.

6. Negative Capability

One of Keats's most famous ideas is Negative Capability. In a letter to his brothers, he wrote that a great poet must be able to remain "in uncertainties, mysteries, doubts, without any irritable reaching after fact and reason." This means that a poet should not try to explain everything logically. Instead, he should feel and imagine.

This philosophy makes Keats's poetry very special. His poems do not give final answers or fixed truths. Instead, they allow readers to experience emotions and thoughts freely. For example, in *Ode to a Nightingale*, Keats does not tell us whether imagination truly offers escape from death; he leaves it open. This mystery makes his poetry deep and beautiful.

7. Keats's View of Life and Death

Throughout his short life, Keats was surrounded by illness and loss. His own sickness and the death of his loved ones made him think deeply about mortality. But instead of being negative, he found ways to make pain meaningful. He saw death not as an end, but as part of the natural process of life.
