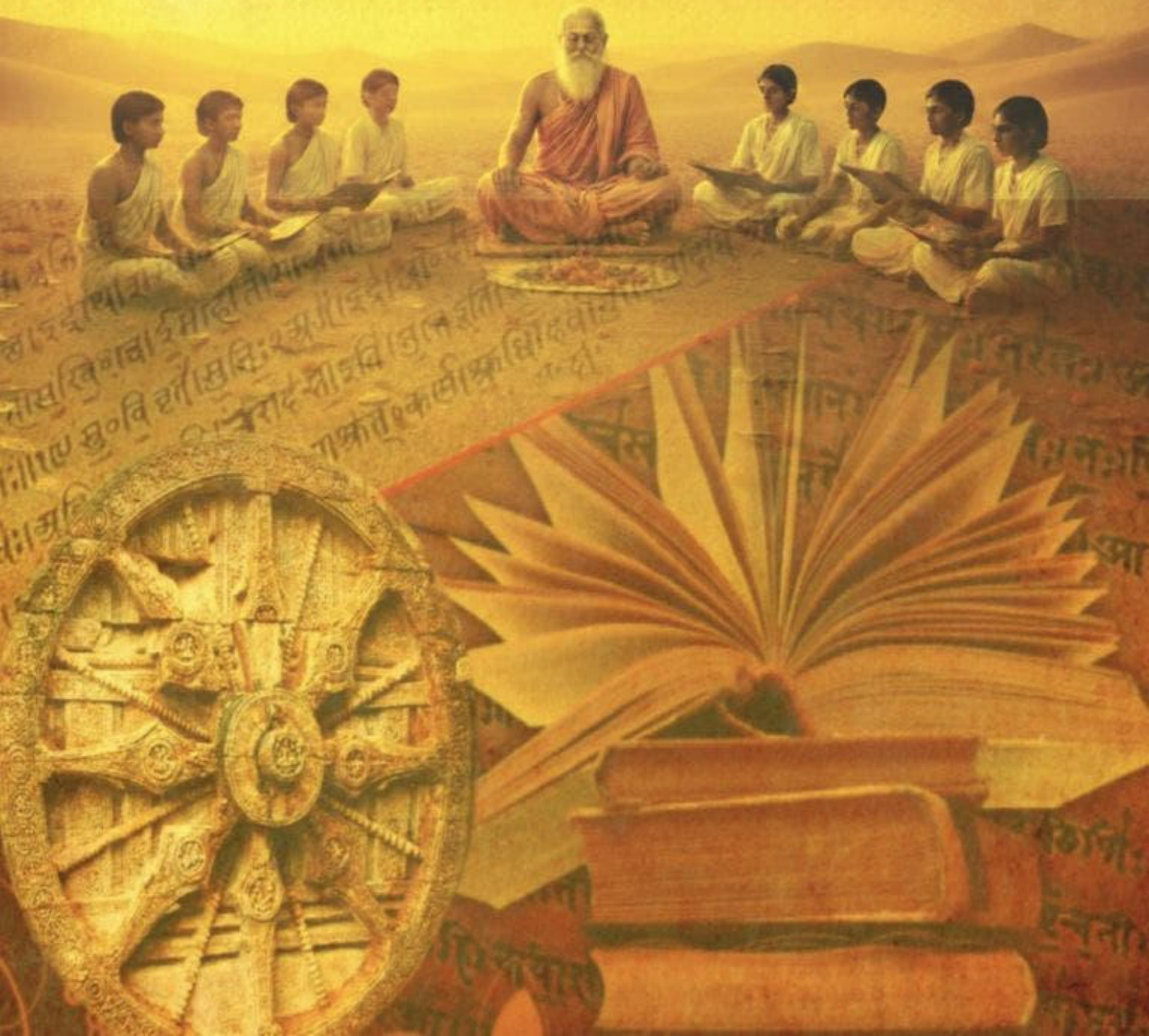

The Position of Women in Victorian Literature
